The parking is limited, so if possible, please use public transportation. Also, please note that surrounding roads may be congested.





AIMING TO ENSURE TAX FAIRNESS

Efforts are being taken to sort out delinquent city taxes to ensure tax fairness and securing financial resources.

Taxes are an important source of revenue for making our city more prosperous and livable and taxes must be paid voluntarily by the established deadline.

Delinquent tax collection is a series of operations performed when municipal taxes (city/prefectural tax, property tax/city planning tax, light vehicle tax, National Health Insurance tax, etc.) are not paid by the due date.

In order to maintain fairness in the tax burden, the city has not only provided prompt tax payment guidance through the Tax Payment Information Center, which was launched in fiscal year 2021, but also worked with collection counselors who have specialized knowledge to help sort out delinquent taxpayers.

INTRODUCING INITIATIVES TO ELIMINATE DELINQUENCY



If you are having trouble paying your taxes, please consult us as soon as possible.

If you are temporarily unable to pay your taxes by the due date because of unavoidable reasons such as illness, unemployment or business closure, please be sure to contact us before the due date. We provide consultation on payment plans to complete payment, including interviews about living conditions. If you do not consult with us, your situation may not be understood and your property may be seized. Please don't leave things as they are, make it a priority to seek advice.

In Fiscal Year 2023, we are particularly strengthening efforts to sort out delinquent tax payments for the current year (delinquent payments before next year's tax is levied). In the city, the Tax Payment Information Center provides tax payment guidance for those who are in the early stages of delinquency.

In Fiscal Year 2022, guidance results are as follows: Telephone information 2,910 cases. Document information 8,805 items.

Summary of Sakura City Tax Payment Information Center.

Operations: ◆After sending a reminder letter for city tax, etc., we will provide payment guidance to those who have not received payment confirmation for approximately one month by telephone or in writing and will mainly notify those who have forgotten to pay. We are making early efforts to reach out the

public. ◆ The center also reissues lost city tax payment slips and sends application forms for account transfers.

TAX PAYMENT INFORMATION HOURS

On weekdays (excluding holidays, year-end and on the second Sunday). New Year Holidays: 9:00 ~ 17:00 ☎ 484-6117 ⚠ If you do not pay your taxes by the due date, you will be charged a late fee in addition to the actual tax. The rate of late fees is much higher than the interest rate on deposits at banks, etc. In 2023, the rate of late fees is 2.4% per annum until one month has passed from the day after the payment deadline and after that the rate of late fees is much higher, 8.7% per annum.

FLOW OF DELINQUENCY DISPOSAL

- ① Sending of tax notices. If payment is not made within the deadline:
- ② A reminder is sent. If the payment is still not made:
- ③ A property investigation is carried out, investigating financial institutions, workplaces, life insurance companies, etc.
- 4 Seizure: Property, deposit savings, salary, life insurance, real estate, etc.
- S Collection: Seized property is converted into cash and applied to taxes.

NOVEMBER IS CHILD ABUSE PREVENTION MONTH!

Child abuse is an act that injures the mind and body of a child and violates human rights. Early discovery and support will protect children and families. If you notice any worrisome signs or have concerns about child rearing, please contact the consultation counter. You can report abuse anonymously. Even if the result turned out not to be abuse, you will not be held liable. The confidentiality will be protected.

CHILDREN'S MEDICAL EXPENSES SUBSIDY FOR HOSPITAL VISITS AND HOSPITALIZATIONS

In order to support families raising children, medical expense subsidies for hospital visits and hospitalization, which were previously available to children up to the third year of Jr. High School, will be extended starting November 1st to children of the equivalent age of High School until March 31 after the child turns 18 years old.

You will need a receipt to receive the subsidy. If you have not yet applied for a benefit ticket, please do so as soon as possible.

To receive the subsidy from November 1, 2023, please complete the application procedure by December 1, 2023. After this date, qualification will be granted from the date of application.

School supplies expenses will be provided for children entering Elementary School!

To be eligible for this benefit, applicants will have to fall under all the following items:

●Those who are in financial distress (of income) to an extent equivalent to public assistance. (Households where the total income of all members of the household is less than 1.3 times the standard amount of public assistance. ※Those who are

already on welfare are not eligible for this benefit.

If tax declaration is not filed, it cannot be certified.

Parents of new first graders who will enter Public Elementary School in April, 2024. If you are unsure about

where to enroll your child, please consult us.

If you find something abnormal on the road, you can report it on LINE App!

You can now report abnormalities such as road damage, dirt and fallen objects, etc. through situation photos and location obtained from your mobile phone and reporting to The Ministry of Land, Infrastructure, Transport and Tourism's LINE App. The current target area is roads within Chiba Prefecture. Reports can be made 24 hours a day but receipt confirmation will be made during office hours (8:30 ~ 17:15 on weekdays).
