Please note that reservations cannot be made by phone or at the counter. Also, when submitting a completed tax return, reservations in advance will not be required.

The Sakura City Museum of Art, open since 1994, was built in consideration of the preservation and utilization of the former Kawasaki Bank, Sakura Branch (a designated tangible cultural property of Chiba Prefecture built in the Taisho era).

The Sakura City Museum of Art collects works by artists associated with Sakura City and Boso region, with a collection of approximately 1,600 pieces, including works by western-style painter Asai Chū, metalworkers Katori Hotsuma and Tsuda Shinobu.

Up until now, we have held various exhibitions and provided art experiences to citizens. As related projects to each exhibition, we also hold events to widely introduce young artists based in Sakura and the Boso region, such as talk events and workshops with the artists themselves and related parties. The Sakura City Museum of Art will continue to work towards becoming a museum that everyone can enjoy.

This year, to commemorate the 30th anniversary of the museum's opening, we are planning to hold an exhibition on picture book author Edward Gorey among other displays. Please come by all means!

### Sakura City Museum of Art New Year Exhibition.

At this 40<sup>th</sup> Exhibition, works of paintings, crafts, sculpture and calligraphy by contemporary artists based in Sakura City will be introduced.

## **CERAMIC ARTIST: WADA AKIRA**



Mr. Wada is a ceramic artist who grew up in Sakura since he was an elementary school student. Last year, his first solo exhibition "WALK ON THE EDGE" was held at the Sakura City Museum of Art. Mr. Wada developed his talent at a young age by winning awards at numerous ceramic art exhibitions in his 20's and is currently active at the forefront of the ceramic art world based in his hometown Sakura.

After graduating from Bunka Gakuin Ceramics Department in 2001, he studied under master craftsman Uwataki Katsuji. In 2005, he became independent and built a kiln. In 2007, at the young age of 28, he won the Japan Crafts Association Award at the New Ceramics Exhibition.

His work has received high praise and has won awards at numerous ceramic art exhibitions. His works are characterized by sharp straight lines and curves, and contrasts between light and shadow created by a technique of thickly rolling porcelain clay on a potter's wheel and carving it out like a sculpture.

Why don't you visit "the seven gods of good fortune" while taking a leisure stroll in Sakura, a town that has been certified as a Japanese heritage?

♦ Sale of vermillion paper seals: 400 Yen each. You can obtain them from 10:00~16:00 at each temple and shrine, at the Ichioka Japanese sweets parlor, the Sakura Tourism Association and Tezukuri Kōbō Sakura.

※For 2,000 yen you can buy at Tezukuri Kōbō Sakura and Ichioka Japanese sweets parlor a fully-stamped notepad from all temples and shrines.

- Ichioka Japanese sweets parlor will open from Jan. 1 (Mon/Holiday) until Jan. 10 (Wed), closing on Sundays and holidays.
- Tezukuri Kōbō Sakura will open from Jan. 3 (Wed) until Jan.10 (Wed) closing on Mondays as well as the first and third Tuesdays.
- Sakura City Tourism Association. Closed Jan. 1 (Mon) ~ 3 (Wed)

### ♦ Vermillion stamps' fees for each temple and shrine.

One stamp of a vermillion seal costs 200 yen (300 yen for the two stamps of *Makata Jinja Shrine* and *Daishōin*). You can obtain them from Jan. 1 through Jan. 10 and on the 10<sup>th</sup> of every month from 10:00 ~ 16:00)

※Daishōin no Daikokuten and Shorinji Bishamonten are hidden Buddhas and cannot be viewed.

\*Those who buy a stamped seal will receive a tin badge as a gift. Please note that the giveaway will end once we run out of stocks.

### **Accepting Applications for Municipal Housing**



Application forms will be available from **January 9 (Tue)** at the City Hall, Housing Section (Jūtaku-ka), city branch offices, Yatomi branch office, Nishishizu citizens' service center and Sakura citizens' service center). Please see the "Information on Tenant Recruitment" enclosed with the application documents for information on available housing, etc.

Applications will be accepted January 16 (Tue) from 8:30 through January 31 (Wed) until 17:15 hrs. Please attach the necessary documents to the application form and bring them to the City Hall, Housing Section. Post mailed documents are not accepted.

Eligible residents are those who meet all the requirements below:

- ① Living in Sakura City for more than one year and paying city taxes on time.
- ② Living or planning to live together with at least one relative (However, the use by one person is allowed under certain conditions)
- 3 Having obvious and actual housing difficulties and it is clear that the house is actually in need.
- The monthly income is within the prescribed limits:
  - •158,000 yen or less of monthly income for general households.
  - •214,000 yen or less of monthly income for discretionary households (Those that meet certain conditions, such as for the elderly and people with disabilities).
- Neither the applicant nor his/her relatives are members of a gangster organization.
   \*The rent is determined every year according to the income of the resident and housing conditions.
