If you need to file a final tax return (Municipal/Prefectural) please prepare it as early as possible and file it within the deadline. If possible, please complete your tax return at home and submit it electronically or by mail.

The tax return forms are currently being distributed at the City Hall on the 2nd Floor lobby of the main building. (There is a limited amount of forms, so there won't be any available as soon as we run out of them). The forms can also be downloaded from the National Tax Agency website (Kokuzeichō). The forms will also be distributed until March 15 (Fri) at each branch office, dispatch offices and service centers. (For those who submitted the prefectural tax return last year, the tax return was sent out by the end of January.



Who needs to file a tax return?

INCOME TAX - Inquiries: Narita Tax Office, 20476-28-5151

People in any of the following situations must file an income tax return:

- 1. The person's total employment income in 2023 was more than 20 million yen (January ~ December)
- 2. Received a salary from only one employer, and the total of various kinds of non-salary income was more than 200,000 yen in 2023.
- Received a salary from two or more employers, and the total amount of "(income not subject to the year-end adjustment) + (various kinds of income, besides salary and/or retirement income)" was more than 200,000 yen in 2023.
- 4. Income tax has not been withheld from the person's monthly salary and are subject to income tax.
- 5. The balance of "(total income in 2023) (income deduction)" gives a positive amount*

People in either of the following situations do not need to file an income tax return:

- 1. All income was from a salary, and the year-end adjustment has been made by the employer; or
- 2. No income was subject to income tax (for example, survivor's pension and unemployment insurance benefits are not taxable).
- 3. If the "Income from Public Annuities, etc." was 4 million yen or less and other "Miscellaneous Income" was 200,000 yen or less, a tax filing is not required. This shall not be applied if annuities from overseas are included. However, please note that you may receive a tax refund depending on the declaration.

RESIDENCE TAX - Inquiries: Shiminzei-ka (Municipal Tax Section) of Sakura City Hall, \$484-6115

Anyone registered as a Sakura citizen as of January 1, 2024 and meets any of the following conditions must file a residence tax return:

- 1. An unemployed person with business income (e.g. from sales, agriculture, real estate, etc.) less than the minimum income tax filing requirement.
- 2. A salary earner or public pension recipients (pension income of 4 million yen or less) who also had an income of 200,000 yen or less in total.

Recommended to declare but not required:


- 1. Those who are dependent on another household.
- 2. Those who did not have income during the previous year 2023 and were not dependent on anyone
- 3. Those who have deductions for city and prefectural taxes (social insurance premium deductions, life/earthquake insurance premium deductions, etc.)

On the other hand, those who meet any of the following conditions do not need to file a residence tax return:

- 1. Have already filed or will file an income tax return.
- All income was from one salary and a payroll report has already been submitted to the City Hall by the employer.
- 3. A dependent family member listed on the tax return form or payroll report of any other member in the same household.

TAX RETURN FILING VENUES

Changes from this year. Advanced reservations are required for preparation/consultation at the Chūo Kōminkan (Central Community Center). \Re If you are only submitting, a reservation is not required.

◆<Bus information> Take the Chiba Kotsu bus "AEON MALL bound" from Platform 6 at the Central Exit (West Exit) of Keisei Narita Station. It takes about 10 minutes to arrive at the mall.

♦ Admission numbered tickets for the day will be distributed from 8:30 (until 9 AM) on the 3rd floor of the multi-story parking lot. These can also be obtained in advance with an assigned date and time by adding a friend to the NTA official account of LINE app.

If not created within the reserved time, we may decline your consultation as it may be difficult to accept your request.

*During the opening period of this venue, the City Hall will not be able to accept consultations or submissions of tax returns.

If circumstances like the spread of infectious diseases occur, preparation/submission at the venue may be reduced or canceled.

Please note that assistance in preparation of the following items is provided only at AEON MALL Narita. Chūō Kominkan cannot handle preparation on them.

•Those with income other than salary or public pension (excluding personal belongings). •Special deduction for housing loans, etc. (excluding those already adjusted at the end of the year). •Declaration of lost earnings. •Declaration of foreign tax credit. •Declaration of donation deduction other than hometown tax. •Declaration of income related to sales, agriculture, real estate, interest, dividends, transfers, temporary income and retirement income. •Declaration of future transactions. •Declaration of gift tax and consumption tax. •Quasi-final return (deceased/moved abroad). •Declarations for 2022 or before. •Other declarations with complex calculations or declarations requiring judgment by the tax office.

What documents are needed for filing?

When filing a tax return at the Central Community Hall, you will need ▶Your individual number (My Number card) ▶ Notification showing reservation date & time. ▶ Writing utensils/calculator. ※If you are using other venues such as Aeon Mall Narita, please call the Narita Tax Office ☎0476-28-5151 regarding the required documents for final tax return.

For those who don't have My Number card: ►A document verifying your individual number such as the notification card (Tsūchi card) or copy of the resident certificate (Jūmin-hyō). Any of them showing the individual number. ►Identity confirmation documents: show any of the following documents that verify your identity such as driver's license, passport, pension book (Nenkin techō), Health insurance card (Kenkō Hokenshō), disability card (Shogaisha techō).

When consulting and preparing tax returns at the venue, please present the originals of each required document.
 ●For submissions, please attach and submit the originals of each required document (Only copies of identity verification documents).
 If you only submit, there is no need to attach a withholding tax slip.



SAKURA-SHI SAIGAI KYOSAI (COOPERATIVE INSURANCE) FOR FY 2024

Kiki Kanri-ka (Crisis Management Section) 2 484-6131

Sakura City sponsors an inexpensive insurance program that offers its residents a certain level of coverage for damage to residential buildings due to fire, lightning, gas explosion, storms, heavy rain, tornadoes, wind, flood, etc. and human losses caused by such damages.



◆A head of a household who is registered as a Sakura resident is eligible to enroll in this cooperative

Insurance premium & period: Costs ¥1,000 per household per year (Same amount for mid-term participants). People from the same household with the same resident card can join together. The period starts on April 1, 2024 (or the day following the actual application day). The insurance period ends on March 31, 2025. The application period starts on February 1 (Thursday).

◆PERSONAL INJURIES & DEATHS: The maximum benefit is ¥1.2 million for death. For injuries, the benefit will be paid according to the period of injury treatment.

CONGRATULATORY MONEY FOR CHILDREN IN SINGLE-PARENT HOUSEHOLDS

Kodomo Katei-ka (Child and Family Support Section) **2** 484-6140

Eligible children are those in single-parent families who will enter elementary school, Jr. High School or High School in April this year or who will graduate from Jr. High School and seek employment. (Those families who are raising eligible children in place of parents will receive this benefit too.

By the end of this month, documents requesting financial aid will be mailed to families eligible for child rearing allowances, single-parent families, etc. who are eligible for medical expenses, etc. If you have not received your documents but would like to check if you are eligible, please contact us. Payment amount: 10,000 Yen per eligible

Application period: Feb. 1 (Thur) to Feb. 29 (Thur). (Postmark valid)

If the deadline has passed, we will no longer be able to pay the benefit. Please be sure to request within the indicated period.

IN THE PRENATAL AND POSTNATAL PERIODS A NATIONAL HEALTH INSURANCE TAX **EXEMPTION SYSTEM BEGINS**

Kenkō Hoken-ka (Health Insurance Section) **2**484-6125



Starting this month, a system has started in which those who have given birth will be partially exempted from paying National Health Insurance taxes during the prenatal and postnatal periods.

Eligible people are those who have given birth after November 2023 or are currently planning to give birth and are insured by the National Health Insurance. includes delivery after 85 days of pregnancy or more, stillbirths and miscarriages, induced abortions and those who have given birth prematurely).

From January 2024 onwards the National Health Insurance tax is eligible for exemption.

*The exemption period is for a total of 4 months.


※In case of a multiple pregnancy, the exemption period is for a total of 6 months.

EXTRAORDINARY SUPPORT BENEFIT FOR CHILDREN

In light of the impact of soaring prices, households with children



Benefit amount: 10,000 Yen per eligible child. Payments have already been made to those who received the child allowance "jido teate" in May 2023. Civil servants and households whose income exceeds the child allowance income limit must apply. (Application forms have already been sent to eligible people). Please see the website for information on children born between Feb. 1 ~ April 1, 2024.

SPECIAL BENEFITS FOR LIFE SUPPORT IN CHILD-**REARING HOUSEHOLDS**

Low-income households with children who are particularly affected by the soaring prices of food and other items will be eligible.

Benefit amount: 50,000 yen per eligible child.

There are three types of benefits: (1) Single-parent households, 2non-single parent households and 3cityspecific benefits. Please apply for the type that meets the payment requirements.







The allowance has already been paid to eligible children's accounts. However, those families whose finances have suddenly changed need to apply.
