ATEST INFORMATION REGARDING VACCINATIONS AGAINST THE NEW CORONAVIRUS INFECTION



The third vaccination has started for children over 12 years old who have been inoculated for more than 6 months since their second vaccination. The inoculation is based on the will of each citizen but please consider it. It is said that there is a possibility that the third vaccination can enhance the infection prevention effect as well as the aggravation prevention effect. For more information, please refer to the Chiba Prefecture Ministry of Health, Labor and Welfare website. During the Golden Week holiday, opportunities for contact with people will increase so we ask for your cooperation to avoid the spread of the infection and thoroughly implement control measures.

TO THOSE MOVING INTO THE CITY

You cannot be vaccinated with the vaccination ticket from your previous address. Inoculation tickets will be mailed to those included on the groups ①~③ (No application required) The table below shows the vaccination ticket to be mailed and the period until issuance.

If you do not receive your vaccination ticket within 3 weeks after the transfer procedure:

If you have been vaccinated for the first or second time before moving in and you cannot confirm the vaccination record in Sakura City, you may not be able to receive the third vaccination ticket. If you do not receive the vaccination ticket you need, please contact the Vaccinations Call Center. In this case, it will be necessary to submit a copy of your inoculation record (certificate, etc.)

If you need a vaccination ticket in a hurry. such as in the case when the vaccination date has already been fixed, please contact the Vaccinations Call Center but please note that the third ticket can only be sent 6 months after the second inoculation.

To those who have been inoculated overseas

If you have already received the third vaccination overseas, please provide the inoculation information as it will be required when the fourth vaccination ticket is issued. If your last vaccination history was in Japan but in another local government, application will not be necessary.

JIDŌ TEATE (CHILD ALLOWANCE) Starting June, part of the child allowance system will change.

Kodomo katei-ka (Child & Family Support Section) ₹ 484-6140

In principle, you do not need to submit a current status report (*genkyō todoke*) but those who fall under any of the following points must submit a status report. If you fail to submit this, you will not be able to receive the allowance after June.

- Those who receive the benefits in a city, ward, town or village that is different from the address of the residence certificate due to violence from the spouse.
- •Guardians of minors, institutional recipients/foster parents and those instructed by the municipality to submit the application.
- •Income upper limit will be set. If the income of the person raising the child is above the upper limit of income, the child allowance will not be paid (From October 2022 payment amount). If the income falls below the upper limit of income, a certification will be required.
- ■If you are relocating, you will be required to report it.
 The following are also cases that are deemed to report:
 ■In the case of a recipient whose eligible child's whereabouts are undetermined.
 ■When the spouse recipient remarries and changes the child's address/name.
 ■When the spouse who was raising the child has unknown whereabouts.
 ■When there is a change of pension for beneficiaries who have a child under 3 years old.
 ■When receiving designation as "parents designated" by parents living overseas.
 ■When the beneficiary is a civil servant.





A light vehicle tax is levied for any light vehicle (including mopeds, small bikes, small-sized special vehicles, and three- and four-wheeled light vehicles) as of April 1 each year. The applicable tax rate differs depending on the vehicle type and the date of the First-Year Inspection (FYI).

The deadline for light vehicle tax payment is May 31 (Tuesday).

Making your payments via a transference is convenient and reliable, just make sure to check the balance of your account before making the payment.

Please pay by the due date at the nearest banking institution or convenience store.

SPECIAL BENEFITS FOR HOUSEHOLDS EXEMPT FROM RESIDENCE TAX AND THAT HAVE BEEN AFFECTED BY THE CORONAVIRUS INFECTION

Target households are those who fall under the next categories

- ① Households exempt from residence tax as of December 10th, 2021 and that have been affected by the new coronavirus infectious disease.
- We have suffered sudden changes in household budget and that after January 2021, their budget is below the level equivalent to tax exemption.
 - ♦ The benefit amount is 100,000 yen per household. ♦ ① and ② cannot be combined together.

 Procedure method:
- ① A confirmation letter will be sent to eligible households. As a general rule, the deadline for submission is within 3 months from the date of issue of the confirmation, so please submit it as soon as possible.
- ② To qualify for the benefit, an application is necessary. Based on the household situation at the time of application, the income of households subject to the residence tax for the FY 2021 will be judged. ※ Households that have received benefits before are not eligible.

After examining and confirming documents, payments for eligible households ①and② will be carried out by wire transfer and will take about one to one and a half month. Applications can be accepted by post mail. The documents required for application are posted on the city homepage (QRC) and are also distributed at the Social Welfare Section, city branch/dispatch offices, Sakura City Council of Social Welfare and Living Support Center Sakura.
